

Income & Needs Eligibility Criteria

1.

Needs Criteria

The program prioritizes services for families who demonstrate the greatest need:

- Children under Child Protective Services: Children who are under the jurisdiction of CPS or have been identified as at risk of abuse, neglect, or exploitation are given priority.
- **Families Experiencing Homelessness:** Families lacking a fixed, regular, and adequate nighttime residence receive priority consideration.
- **Children at Risk:** Children identified as at risk of neglect, abuse, or exploitation, but not currently under CPS, are eligible.
- Recipients of Governmental Program Benefits: Families already receiving benefits from certain governmental programs, such as CalWORKs, are eligible under this criterion.

2.

Income Criteria

Families must fall within the income limits set by the state, which are updated annually. These limits are based on family size and income levels.

Family Income: Families must fall within certain income thresholds, which are periodically updated to reflect the cost of living and economic conditions in California

3.

Other Criteria

- Activity Requirement: Parents or guardians must be engaged in work, job search, education or training activities
- Residency: Applicants must be residents of California.

The eligibility process involves filling out an application, proof of income, activity status and residency, among other documentary requirements.

What is CCTR?

The California Department of Social Services (CDSS) administers the CCTR program, which stands as a cornerstone in the state's effort to support families in need of affordable childcare. This program is designed to serve a broad spectrum of California's population, particularly low-income families, by providing access to quality childcare and development services. These services are not only aimed at nurturing a child's cognitive, emotional, and social growth but also at enabling parents to engage in productive activities such as employment, education, or training programs.
